<p>The Promotion & Tenure (P&T) Advisory Committee shall consist of four tenured regular faculty members in the Department of Biomedical Sciences. At least two members will hold the rank of Professor. Terms of service will be three years, with the exception of a possible one year extension to provide continuity on the committee should more than one member be completing his/her term in a given year. New members of the Committee will be elected in January and service on the committee begins immediately following election. Each year the P&T Advisory Committee will elect a full Professor on the Advisory Committee to serve as its Chair. No Department of Biomedical Sciences faculty member may serve more than two consecutive terms on the P&T Advisory Committee.</p>
